Financial Summary

Auditors Qualification

The Reporting Accountants have expressed a clean opinion (i.e. unqualified with no referrals) on the accounts for the period ended 31/01/2015.

Turnover

Turnover has increased from GBP 27,377,000 to GBP 30,128,000, a growth of 10 % in the period.

Operating Profit

Totalled GBP 913,000. In the year prior a Profit of GBP 298,000 was achieved.

Pre Tax Profit

The subject's profit increased by 56,800 % in the year.

Working Capital

The company's working capital has increased by 30 % in the period.

Net Worth

The company's negative net worth decreased by GBP -458,000 and at the year end was GBP 5,631,000.

Fixed Assets

The subject's fixed assets increased during the year by GBP 209,000 to GBP 1,403,000 and are now 16 % of total assets compared with 15 % in the previous year.

Long Term Liabilities

The company's long term liabilities increased during the period by 2% and are now 161 % of net worth compared with 145 % in the previous period.
